FURTHER, THE UNDERSIGNED RELEASES, DISCHARGES, AND AGREES TO INDEMNIFY AND HOLD HARMLESS THE MEDFORD CURLING CLUB AND ITS ORGANIZERS, OFFICERS, EMPLOYEES, AND VOLUNTEERS, THEIR SUCCESSORS, INSURERS, AND ASSIGNS FROM ANY AND ALL LIABILITY, PERSONAL INJURY, AND PROPERTY DAMAGE, AND ANY AND ALL LOSS WHATSOEVER ARISING FROM THE NEGLIGENCE OF ANY SUCH INDIVIDUAL OR ENTITY, AND THE UNDERSIGNED CHILD'S PARTICIPATION IN ANY ACTIVITIES RELATED TO CURLING PRACTICES, GAMES, TOURNAMENTS, AND OTHER ACTIVITIES SPONSORED BY, ARRANGED BY, OR LOCATED AT THE MEDFORD CURLING CLUB.
